e-TENDER NOTICE

<u>INVITING e-Tender For Helicopter Service in state of Jharkhand for various Pilgrimages/ Tourist</u> <u>Places/ Commercial uses in Jharkhand on the basis of PPP Mode.</u>

1. The **JHARKHAND FLYING INSTITUTE** "JFI" (A Society Registered under Dept. of Cabinet Secretariat and Vigilance (Civil Aviation Division), Jharkhand invites e-Tender from Service Provider or Non-Scheduled Operator's Permit (NSOP) holders for Helicopter Service in State of Jharkhand. The Seating Capacity should be not less than 1+6 with single-engine Helicopter under VFR.

The State of Jharkhand is considered to be various of the most important pilgrimages and sanctified holy places of the Hindu in the world. In addition, there are many other tourist places in Jharkhand where the Helicopter Service will be beneficial for the public.

2. The JFI Proposes a helicopter service in Jharkhand on PPP Mode, in which the service is to be operated as a Joint Venture (PPP Mode) through the agreement, on the following terms and agreement-

- a) The JFI decisions to operate Helicopter on sharing basis of minimum 60 Hours of flying guarantee per months. The bidder shall invest in a 50:50 ratio for the procurement of Helicopter on offered type.
- b) Profit Sharing:- Provision of profit share of outcome in terms of financial shall includes expenses such as ground handling, temporary base setup for maintenance during operations in Jharkhand, deployment of manpower, fuel barrels, and other operational charges related to helicopter operations. The calculation will be calculated by authorised CA of the JFI.
- c) Initial Operation Period:- The operation will commence for an initial period of 01 Year which will be extended as per mutual understanding.
- d) Helicopter service can be used for other purposes as and when required by JFI.

3. For commencing the Helicopter services the JFI Society will provide:-

- a) Well-equipped and developed Helipads along with Crew Rest Room at Basukinath Helipad. The Maintenance facility may be developed by the Service Provider at their own expense or may be consider to station at nearest State Govt. owned airport.
- b) Shall provide temporary Helipad at other places and necessary permission for the operation of helicopter.
- c) Security of the Helipad and Helicopter during Helicopter operations shall be provided by JFI.
- d) Free Landing and parking at Helipads.
- e) Government Advertisement.
- f) Payment Gateway for Online Booking.
- g) To seek necessary approvals and permissions from local authorities.

4. Responsibilities of Operator Service Provider:-

- a) To provide a Helicopter Service in state of Jharkhand at various Pilgrimages/ Tourist Places/ Commercial uses in State of Jharkhand as required.
- b) To operate a Helicopter for the above said services.
- c) Passengers liaising such as safely embarking and disembarking of passengers.

- d) Ground handling, Passenger handling.
- e) Temporary base setup for maintenance during operations in Jharkhand,
- f) Deployment of manpower, including transportation and accommodation,
- g) Marketing, Advertisements, website, and APP development if needed.
- h) Ticket Booking Arrangements.
- i) Necessary Clearance/ Approval of helicopter operations for helipads from DGCA, GoI for which all necessary help will be provided by JFI.
- j) Other Miscellaneous Work related to this Service.
- k) Liabilities of incident/accident shall be the responsibility of the operator.

5. The interested service provider meeting the below-mentioned criteria may submit the details as follows:-

- a) Experience certificate/Declaration in the operation of helicopters in India.
- b) Offered helicopters must be approved by DGCA under NSOP and seating capacity should be not less than 1+6 with single-engine Helicopter persons excluding crew. The technical specification of offered Helicopter and Valid C of R, ARC and a copy of NSOP Registered in their of valid Insurance of helicopter with seat insurance. Registration of Company and their related documents i.e. PAN/GST/Certification of incorporation etc.
- c) If service provider hired a helicopter from NSOP holder, then in the case of such service provider shall give undertaking on stamp paper or submit an agreement with operator.

6. The service provider has to submit the following documents for Technical Bid:-

- a) Name of Company & Registration.
- b) Type of offered Helicopters including seating capacity.
- c) NSOP Certificate or Agreement/LoI copy of hired with NSOP holder.
- d) Valid Seat insurance of offered helicopters.
- e) Valid PAN & GST of the company.
- f) Experience Certificate of Operations.

7. Selection Process-

The bidder must Quote the profit Sharing in financial, percentage in terms of H1 basis. The H1 bidder will be offer to operate Helicopter in state of Jharkhand.

8. The service provider must full-fill the following requirement in Financial terms:-

- a) The interested service provider shall have to submit earnest money of Rs. 5.00 Lakhs and Rs. 25,000/- only for tender fee through online mode by Net Banking option or Through NEFT/RTGS Challan mode.
- b) Bidder's EMD amount will be refunded into the same Bank account through which online payments have been made after rejection in a tender at any stage.
- c) However, H1 bidder will be asked to submit performance security amount before online AOC (Award of Contract) process in the form Demand Draft in favour of **Jharkhand Flying Institute** payable at **Ranchi**, hard copy of DD must be submitted at the office of Managing Director, Jharkhand Flying Institute, State Hangar, Birsa Munda Airport Road Hinoo Ranchi-2. The successful bidder shall have to submit as a security deposit, a performance bank guarantee of not less than 15% of the bid value within 7 working days after receipt of LOI. The bank guarantee must be issued by any Indian nationalized or scheduled commercial bank in favour of Jharkhand Flying Institute, payable at Ranchi. In case, the contract is further extended beyond the initial period, the Bank Guarantee will have to be accordingly renewed by the successful bidder. A sample copy of Bank Gurantee is attached herewith as Annexure-'A'.
- d) After AOC process online submitted EMD Amount by H1 bidder will be refunded into the originated bank account used for the payment of Tender Fee and EMD.
- e) Important Notes regarding Online Tender Fee and EMD Payment-Tender fees and EMD will be received through online mode only. Bidders can use internet banking facility for faster processing of tender fee and EMD. Alternatively, Bidders can use the NEFT/RTGS challan generated for the tender from jharkhandtenders.gov.in portal.

Refund will only be issued to the originated bank account used for the payment of Tender fee and EMD. So, Bidders are advised NOT to close the Bank Account used for online payment/(NEFT/RTGS) of tender fee and EMD.

NO Hardcopy/Physical copy is required to be submitted for tender opening/ Evaluation. However JFI may ask original documents for verification before award of contract.

- 9. The company has to submit a single quote for fixed monthly charges and percentage of profit sharing for the JFI. Higher profit share for JFI will be the base of selection (H-1) during scrutiny of the financial bid. The profit percentage must be quoted in the format of the financial bid attached herewith Annexure-'B'.
- 10. The tender value of Bid are as follows:
 - a) Single Engine Helicopter Seating Capacity of 1+6 should not more than Rs. 80 lakhs per month (GST as applicable).
- **11.** The above-required documents and photocopy of online payment details must be uploaded through online mode on the website https://jharkhandtenders.gov.in
- **12.** The successful company have to sign an agreement with **JFI**, whose validity period will be initially for 01 Year and may be extended further subject to the satisfactory performance of the company and on the basis of passenger flow.
- **13.** The interested service provider may apply with detail proposal online mode on https://jharkhandtenders.gov.in till 11/06/2025 till 03:30 PM.
- **14.** Only the Technical Bids shall be opened on 12/06/2025 at 03:30 PM for scrutiny of the bid documents and technical data etc. The schedule of events for different activities is given below:-
