**CIRCULAR**

**Revised Landing/Parking/Housing Charges for Private aircraft at Various Government Airports/Airstrips in the State of Jharkhand.**

The Previous CIRCULAR No: CAD/VIII-14/07/490 of 17<sup>th</sup> July, 2023 is being amended on this date for the Private Operators/Vendors/Agencies seeking CAD, Government of Jharkhand Operational Area/Hangar space for the uses at various airports in the State of Jharkhand.

For Landing/Parking/Housing of any aircraft at various airports/airstrips in the State of Jharkhand, the applicable charges on hourly basis shall be in accordance with tabled hereunder :-

**A. For Light Aircraft & Single Engine Helicopter at Dumka/Dhanbad/Hazaribagh/Daltonganj/Giridih/Gumla/Chaibasa the Landing, Parking and Housing charges will be as per the following :-**

**B. For Turbo Prop/Jet & Twin engine Helicopter at Dumka/Dhanbad/Hazaribagh/Daltonganj/Giridih/Gumla/Chaibasa the Landing, Parking and Housing charges will be as per the following:-**

For Short Term and Long Term rent of operational area/hangar space, the Parking and Housing charges for daily/monthly/yearly etc. will be as per the following table :-

**Note:-**

1. The Payment of Landing charges shall entitle aircraft to:-
  - a. The use of aerodrome for arriving and departure only.
  - b. The purpose of training flight charges will be same as per total number of each landing.
2. The Payment of Housing charges shall entitle aircraft to:-
  - a. Park the aircraft inside the hangar space with all available facility as well as permission to use hangar for maintenance purpose, at the concerned airport/airstrip.
  - b. Housing charges is inclusive of parking charges and there will be no separate parking charges is payable for parking of aircraft.
3. Daily charges will be applicable only the aircraft is park for a minimum of 10 hours or else hourly charges will be applicable.
4. The calculation of parking/housing charges of aircrafts will be done as per the tabulated rate above viz. if any operator/vendor requires hangar facility for any light aircraft/single engine helicopter for 50 days then the required charges shall be applicable as per below calculation :-
  - Housing charges (including parking) for 01 month : Rs. 80,000/-
  - Housing charges (including parking) for 15 days : Rs. 50,000/-
  - Housing charges for 05 days (including parking) : Rs. 20,000/-

Total payable charges for 50 days = Rs. 1,50,000/-
5. If the said services/facilities are demanded for 06 months or more then it will be made available under the agreement terms & conditions after the signing the Agreement.

**Other Condition:**

1. Before permitting the Private Operators for landing, parking, housing etc. on above mentioned Terms & Conditions the District Administration may grant the permission to the Operators subject to prior clearance from Jharkhand Flying Institute Cabinet Secretariat and Vigilance Department (Civil Aviation Division), Government of Jharkhand, Ranchi by any of the following means as mentioned below:-

2. Charges incurred to District Administration for provisioning of services e.g. Security, Fire Fighting, Ambulance etc. are chargeable and payable to concerned District administration on actual cost basis.
3. State Government's aircrafts are exempted from all the above charges.

4. When the flight is conducted for training purpose, the necessary clearance of DGCA/MoCA, Govt. of India should be submitted to the department by the operator for approval as compliance of CAR.
  5. The Aircraft Safety, Airworthiness, Mooring, Maintenance & Refueling shall be the responsibility of individual operator and Jharkhand Flying Institute Government of Jharkhand is not liable for any lapses in this regard.

The charges for the said services will be paid by Pilot of aircraft/operator and has to be maintained in separate account book for audit purpose.
